This is a full-time, exempt level position for 195 days per year and includes a long-term Induction and Professional Development Plan.

- 19. Approve the appointment of Kevin Harcarick as Boy's Basketball Coach for the upcoming 2022/2023 school year, along with a stipend of \$2,000.00.
