## **Planning Process**

Bear Creek Community Charter School utilizes a collaborative team approach to develop the plan, coordinated by the Chief Executive Officer. Involvement will include student representatives (Student Council, National Junior Honor Society), parents, staff, administrators and the Board of Trustees. Key planning meetings are held to coordinate involvement; however, stakeholder involvement will also be solicited during regularly scheduled meetings such as PTO meetings, Board of Trustees meetings, Leadership Team meetings and monthly staff meetings. Some of these meetings are held weekly, while others occur monthly.

#### **Mission Statement**

Bear Creek Community Charter School's Mission is to embrace a diverse student body and inspire student success through an innovative curriculum, the cultivation of environmental stewardship, and by holding students, parents, and staff accountable for results.

#### **Vision Statement**

Bear Creek Community Charter School is currently operating at capacity, and has done so for the past ten years. There are hundreds of students currently on the school's wait list. The Board of Trustees will be holding a strategic planning session during the upcoming school year to address the possibility of opening enrollment for additional students based on demand.

# **Educational Community**

Bear Creek Community Charter School is located in a rural setting; however, the majority of students reside in an urban setting. Students attending Bear Creek Community Charter School originate from twelve different local school districts located throughout Luzerne County, Lackawanna County and Monroe County. Healthcare and service-related industries are predominant in Luzerne County. Bear Creek Community Charter School provides a small-school environment, with opportunities for hands-on learning, with an emphasis on environmental education. The School partners with other entities within the local community, such as the Bear Creek Camp, Bear Creek Foundation, and other entities to expand the school's focus on environmental education. Bear Creek Community enjoys a positive and collaborative relationship with municipal government, local business and community organizations. Parents are extremely active in the school, including the School's Parent-Teacher Organization.

## **Board of Trustees Professional Development**

The Board of Trustees receives ongoing professional development in areas important to charter school operations as part of bi-weekly meetings and work sessions, trainings conducted by the school's leadership team, through webinars, the Pennsylvania Coalition of Public Charter Schools and by hosting a bi-annual strategic planning workshops. Topics include fiduciary responsibility, ethics, personnel, operations, finance and school governance, along with legislative updates. Board members have initiated a formal board training program as required by Act 55, ensuring they meet or exceed the legal requirement for ongoing training.

## **Governance and Management**

Administrators and Trustees communicate regularly via electronic mail, and key administrators attend the bi-weekly meetings of the Board of Trustee to provide operational updates and discuss topics of interest. This includes the Chief Executive Officer, Director of Curriculum & Instruction, Director of Student Affairs, Director of Intervention & Support Services and the Business Manager. Other staff attend as required. Administrators also interact with Trustees as part of sub-committees, such as Facilities, Personnel, etc. Trustees often volunteer at the School, providing other opportunities to maintain a positive, collaborative relationship with administration and staff.

#### **Student Enrollment**

Parents of new students interesting in enrolling at Bear Creek Community Charter School will be given the opportunity to participate in an annual Pre-Enrollment Process. The date pre-enrollment begins and ends will be determined by the school administration each year and will be posted in the school office as well as on the school's web site before January 1. Parents of students interested in enrolling in the school must complete and return an accurate Pre-Enrollment Form by the deadline provided by the school.

As permitted by the Pennsylvania Charter School Laws, Bear Creek Community Charter School will give preference in enrollment to the following categories of students, in the following order:

- Returning students (re-enrollment of existing students by posted deadline);
- 2. Children of parents who actively participated in the development (prior to the school receiving its charter) of the charter school (also known as Founder's List);

- 3. Siblings of a currently enrolled student. For the purpose of this policy, a sibling is defined as a child who is related to an existing student by blood or adoption and who share a legal tie to at least one common parent;
- 4. Holdover Students from the prior school year;
- 5. Students residing in the school district in which the charter is located (Wilkes-Barre Area School District);
- 6. Students residing outside the school district in which the charter school is located (all other school districts within the Commonwealth of Pennsylvania).

In the event the number of applicants for any given grade or section exceeds the number of enrollment slots (seats) available, the school will accept students by a random selection process. The school will grant enrollment preference according to the aforementioned criteria. A public lottery will be held, as necessary, to determine enrollment. The date, time and location of the public lottery will be posted at the school, on the school's web site, and in a newspaper of general circulation at least one week prior to the lottery being held. A neutral party will conduct the lottery on behalf of the school. The school will notify applicant parents within 30 days of the lottery with the outcome as to whether their child has been accepted or has been placed on a wait list. The lottery is open to the public.

After all available enrollment slots (seats) are filled, wait lists will be created and maintained for each grade. The initial wait list will be created randomly as part of the public lottery. Following the lottery, additional students will be added to the wait lists on a first come/first served basis. When a slot becomes available in a grade, the parents of the first student on the wait list will be contacted. Acceptance is determined by the parent completing and hand delivering an accurate Pre-Enrollment Form to the school office within twenty-four (24) hours of being notified by the school. If the enrollment slot is declined, if no response is received, or an accurate Pre-Enrollment Form is not hand delivered to the school office within twenty-four (24) hours of being notified, the enrollment slot will be forfeited and the next student on the wait list will be contacted. Once all vacant enrollment slots for each particular grade and section are filled, enrollment will be closed.

#### **Stakeholder Involvement**

Bear Creek Community Charter School solicited input from multiple stakeholder groups using a variety of methods.

Information from professional and paraprofessional staff was solicited as part of our annual Pre-Service Training, which is held prior to the start of the new school year, as well as through ongoing conversations and dialogue throughout the school year. This included engaging in large and small group dialogue about the needs of our student body, opportunities for improvement, and enhancing the educational experience and academic performance of our students. School Leadership often conducts an online survey at the end of the school year to solicit feedback from staff on professional development, school policies, opportunities for improvement, etc.

School administrators were engaged in the process as part of weekly School Leadership Team meetings as well as one-on-one meetings as needed.

Parents were engaged through in-person dialogue with PTO participants, and all parents were provided an anonymous Parent Satisfaction Survey.

Student input was solicited through both Student Council and through the National Junior Honor Society membership.

Information from the parent survey, as well as student, staff and administrator input, was discussed with the Board of Trustees. Parent Satisfaction Survey information was made available to the public through the school web site. Collectively, this input was incorporated into the school's plan.

# **Needs Assessment**

# **Charter School Accomplishments**

#### **Accomplishment #1:**

Bear Creek Community Charter School continues to differentiate itself from its chartering school district and other public schools in Luzerne County through academic performance on the PSSA, engaging parents in the assessment of school operations and through hands-on environmental education programming.

#### **Accomplishment #2:**

Bear Creek Community Charter School has successfully implemented a new English Language Arts series that is Pennsylvania-Core aligned for grades K-8, and continues to provide ongoing professional development to staff related to this endeavor. In support of this new program, the school is working to build classroom libraries with pertinent titles that support the curriculum and appeal to student's interests.

#### **Accomplishment #3:**

Parent Satisfaction. Fifty-four percent (54%) of Bear Creek Community Charter School's parents recently completed an anonymous parent satisfaction survey. Of those responding, one hundred percent (100%) of the parents reported they were satisfied with Bear Creek Community Charter School and would recommend Bear Creek Community Charter School to a friend or family member.

#### **Accomplishment #4:**

Bear Creek Community Charter School successfully implemented a new Math series in kindergarten through eighth grade, and documented the School's Math curriculum to include unit plans, scope and sequence, and ongoing professional development. A documented Math curriculum was previously a concern, as was a Math series that was not Pennsylvania/Common Core aligned. During the 2018-2019 school year, a new process was successfully implemented that included standardized lesson planning, along with a weekly administrative review process.

#### **Accomplishment #5:**

Bear Creek Community Charter School's charter with the Wilkes-Barre Area School District was up for renewal in August 2019. The District raised no concerns regarding school operations, and approved the School's fourth five-year charter renewal six months prior to charter expiration.
